Interfaces are a critical piece of an integrated Solution. Attached is a sample list of the known legacy interfaces, for two Enterprise Partners (CSES and DOH) for the purpose of understanding the types of legacy interfaces. There may be multiple types of interfaces (e.g., Real-time, Batch, Incoming, Outgoing, Bi-directional) going forward but to the extent possible the State would like to move to Real-time interfaces. There will be interfaces for additional Enterprise Partners (e.g., BHSD, ALTSD, CYFD, etc.) and we will update list as the information is available.

Not all of these will be integrated into the new system but the Vendor should consider these as well as the potential for future growth for multiple Enterprise partners.
