<u>Commercial Insurance Billing Program (CIB)</u> – Current Contractor services include monthly Fee for Service (FFS) and encounter claim-specific Carrier interface program that utilizes Contractor's national health insurance eligibility database to identify other insurance and seek recovery for those claims not coordinated by the provider. This service includes billing, claim and recovery management.

<u>Commercial Insurance Disallowance Program (CID)</u> – Current Contractor services include quarterly Fee for Service and Medicare Part A claim Provider interface program utilizes our national health insurance eligibility database to identify other insurance and seek recovery for those claims by communicating the other insurance information to providers and directing them to pursue recovery and reimburse Medicaid upon payment from a primary payer.

Hospital Credit Balance Audit (CBA) – Current Contractor services include Desk and On site Fee for Service and MCO hospital provider interface audits of credit balance accounting, overpayment identification, validation and recovery management.

<u>Credit Balance Audit Long Term Care Providers (CBA LTC)</u> – Current Contractor services include Fee-For-Service and MCO Encounter, desk only LTC provider interface credit balance audit, overpayment identification, validation and recovery management.

<u>Estate Recovery Program (Estates)</u> – Current Contractor services include data and lead driven case identification, development administration and recovery management.

<u>Casualty/Tort Recovery Program (CAS)</u> – Current Contractor services include lead-driven, Fee- for-Service specific case identification, development, administration and recovery management.

<u>Recovery Audit Contract (RAC)</u> – Current Contractor services include Recovery Audit Coordination services.
